- \$25 will pay for a season’s worth of postage

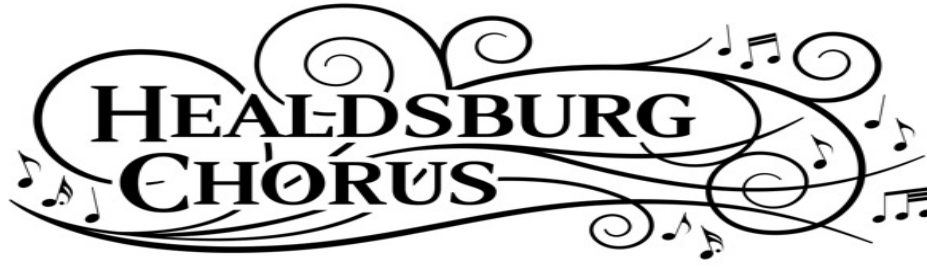
